In accordance with Article 379 of the Turkish Commercial Code ("TCC"), Article 22 of the Capital Markets Law No. 6362 ("CML"), the provisions of the Capital Markets Board's "Communiqué on Buy-Backed Shares" numbered II-22.1 published in the Official Gazette dated 03.01.2014 and numbered 28871, and the issues included in the announcements of the Capital Markets Board regarding Buy-Backed Shares, It has been resolved that

- To determine the maximum number of shares that can be subject to BuyBack as 4,191,000 lots and the maximum amount of fund as TL 160,000,000,
- The maximum duration for the share Buy-back Program to be valid for a maximum of 3 (three) years from the date of approval of the share Buy Back Program by the General Assembly,
- The attached "Gelecek Varlık Yönetimi A.Ş. Share Buyback Program" prepared within these limits was approved at the Ordinary General Assembly Meeting dated 22.04.2025.
